No. 538 of the Year 2016

**The President of the Republic;**

After thoroughly reviewing the Constitution;

Customs Law promulgated by law No. 66 of the year 1963 and amendments thereof;

Decree of the President of the Arab Republic of Egypt No. 184 of the year 2013 promulgating the Harmonized Customs Tariff and the amendments thereof;

The approval of the Supreme Council for the Customs Tariff; And

Upon the proposition of the Minister of Finance;

***DECREES THE FOLLOWING***

**Article: 1**

The customs duty rates stated in decree of the President of the Republic No. 184 of the year 2013 shall be amended as indicated in the list attached to the present decree.

**Article: 2**

The present decree shall be published in the Official Journal and shall come into force as of the day following its date of publication.

**Issued at the Presidency of the Republic on 1 Rabe'i I, 1438 (Islamic Calendar), corresponding to 30 November, 2016 (Gregorian Calendar).**
